Call for Abstracts:

We invite researchers to submit an abstract application to our upcoming Research Forum that provides an opportunity:

- To share findings from *completed* research or
- To share highlights from research *in progress*.

Format of the Research Forum:

Abstract presentations will be selected based on a peer review process. Each presenter will have 10 minutes to present, plus 5 minutes for Q&A. Those selected to present will be notified two weeks prior to the Research Forum.

Proposal Requirements:

Abstracts should be 250 words long include the following:

For completed research:

- Title
- Background
- Methods
- Results
- Discussion
- Implications for MAiD practice
- Authors and presenting authors contact information (email)

For research in progress:

- Title
- Background
- Methods
- Ethics
- Implications and dissemination
- Authors and presenting authors contact information (email)

The deadline for submissions is Friday, March 29, 2024.

CAMAP Research & KT Grants

Applications now being accepted for Spring 2024

CAMAP is committed to supporting MAiD research through grants for new or ongoing research projects, as well as for knowledge transfer. There is \$20,000 available to be awarded over the Spring and Fall 2024 granting cycles, and we hope to fund a number of different projects.

Proposals are reviewed by an adhoc grant review committee (composed of those active in MAiD research themselves who are not submitting an application) and results will be shared publicly on or around April 11, 2024. Priority will be given to projects aiming to understand the MAiD experience in Canada, to improve care and inform policy.

Research Grants: Grants of between \$1,000 and \$3,000 are available (primarily \$1,500 each). They are meant to pay for research assistants, transcriptions, etc.

To submit a research grant application:

We require a one-page (e.g., Word document 12 fond, 450 words) proposal that includes:

- Title
 - Rationale and background
 - Research plan
 - Feasibility of plan
 - Implications for practice
 - Budget

Knowledge Transfer Grants: Grants of between \$1,000 and \$2,500 (primarily \$1,000 each) are available. These are meant to pay for publishing fees as well as other methods of KT.

To submit a knowledge transfer grant application:

We require the following details:

- Abstract of paper (300 words)
 - Description of planned knowledge transfer
 - Budget (e.g., receipt of publication fees)
